CLRTIFICATE OF ARTICLES OF INCORPORATION

THE NAIL MAN, INC.

I, the undersigned, hereby associates myself together of the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the state providing for the formation, Hability, rights, privileges and immunities of a corporation for profit.

Article I
