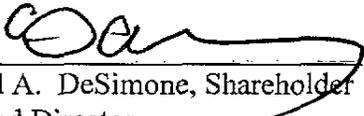

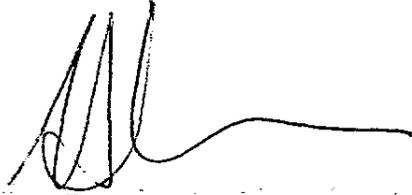
Pursuant to the provision of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

- FIRST:** On February 25, 1997, the Corporation changed its name to South Florida Institute of Sports Medicine, Inc.
- SECOND:** Pursuant to a meeting of the shareholders and directors conducted on January 15, 2003, it was unanimously voted upon and agreed that the name of the Corporation be changed from South Florida Institute of Sports Medicine, Inc. to Orthopaedic & Podiatric Consultants of Florida, Inc.
- THIRD:** The Amendment does not provide for any change reclassification or cancellation of issued shares
- FOURTH:** The date of the Amendment adoption is the date of the special meeting, January 15, 2003.
- FIFTH:** The following resolution was unanimously approved by all Shareholders and Directors: resolve that the corporations name South Florida Institute of Sports Medicine., Inc. be changed to Orthopaedic & Podiatric Consultants of Florida, Inc. and that said may be used by the Corporation subsequent to the filing in the Office of the Secretary of State of the State of Florida.
