ARTICLES OF INCORPORATION FOR GOOD HOPE MANOR, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of incorporation for the purpose of creating a corporation under the laws of the Clate of Florida.

ARTICLE I: NAME

The name of the corporation is GOOD HOPE MANOR, INC.
