The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be PSYCHOLOGY ASSOCIATES OF BOCA RATON, P.A.

ARTICLE II

PLACE OF BUSINESS

The principal place of business shall be situated at 350 West Camino Gardens Boulevard, Suite 301, Boca Raton, Florida 33432 and said corporation shall have the right and privilege of establishing and operating and doing business in such other counties of the State of Florida and in such states of the United States and foreign countries as the Stockholders may from time to time order and establish.

ARTICLE III


