ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is:

DRYWALL STEEL ERECTORS, INC.

Article 2. Mailing Address. The mailing address of the Corporation is:

Article 3. Duration. The duration of the Corporation is perpetual.

Article 4. Purpose. The general purposes for which the Corporation is organized are the following:

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

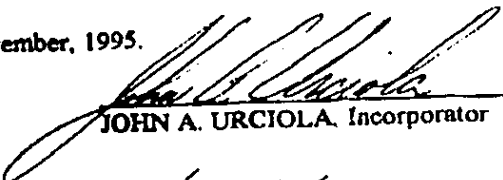
