ARTICLES OF INCORPORATION
OF
NARGIS, INC.

ARTICLE I - NAME

The name of this corporation shall be NARGIS, INC., and the address of the principal office of the corporation is 711 Magnolia Street, New Smyrna Beach, Florida 32168.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock, each share with a par value of \$10.00.
