ARTICLE I

The name of this corporation is E & J TROOST TRUCKING, INC.

ARTICLE II

The general nature of the business to be transacted by this corporation is to carry on any business or to engage in any activity which is permitted under the laws of the United States of America and the State of Florida.

The capital stock of the corporation shall consist of 5,000 shares of common stock at a par value of \$1.00 each.


