

ARTICLES OF INCORPORATION OF  
SOUTH ATLANTIC SHIPPING, INC

FILED  
15 SEP 7 1963

1. The name of the corporation shall be SOUTH ATLANTIC SHIPPING, INC.

2. The corporation shall have a perpetual existence.

3. The purpose of the company shall be to transact any or all lawful business for which corporations may be incorporated under the Florida Corporations Act.

4. The number of shares which the corporation shall have authority to issue shall be:

1000 shares of common stock having a  
par value of \$ 1.00 ( one dollar ) per share.

5. The name of the registered agent is J. Robert Bethel, Esquire. The street address of the corporation's registered office shall be 43 Jean Lafitte Drive, Key Largo, Florida 33037.


6. The address of the corporation's principal office shall be 3001 N.W. South River Drive, Miami, Florida 33142.

7. The stockholders shall have pre-emptive rights.
