

ARTICLE I.

NAME

The name of this corporation shall be The Fishmonger, Inc. and the address of this corporation is 14240 S.W. Canal Road, Indiantown, Florida 34956.

ARTICLE II.

DURATION

This corporation shall have perpetual existence.

ARTICLE III.

PURPOSE



