ARTICLE ONE

NAME

The name of this corporation is :

CERTIFIED CABLE CONTRACTORS, INC.

ARTICLE TWO

NATURE OF BUSINESS

EFFECTIVE DATE
9-5-95

This corporation may engage in any activity of business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporation existence shall begin is: **September 5th, 1995.**

ARTICLE FOUR

CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

A. Designation. The stock of this corporation shall be known as common stock.

B. Authorized. The maximum number of share of Common Stock that this corporation may issue is: **500 shares.**

C. Par Value. Each share of Common Stock shall have the par value of \$1.00.

D. Consideration. Shares of Common Stock may be issued in exchange for cash, real property, labor or services rendered, or any combination of the foregoing. F. Voting Rights. Each share of Common Stock shall entitle the record holder thereof to one vote upon each proposal presented at meeting of the stockholders of the corporation.

G. Dividends. Record holders of Common Stock are entitled to receive their pro rata share of any dividends that may be declared by the Board of Directors out of assets legally available for such purposes.

H. Liquidation Rights. Holders of Common Stock are entitled, in the event of the liquidation or dissolution of this corporation, to receive their pro-rata shares of any assets of this corporation remaining after payment of corporate debts and obligations.

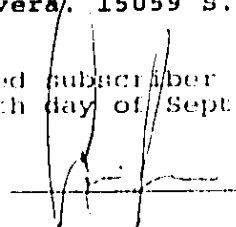

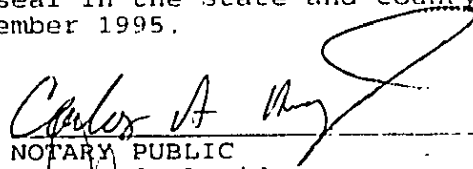

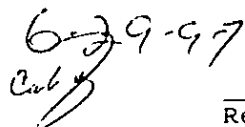
