ARTICLE I-NAME

THE NAME OF THIS COPORATION IS MR. LANDSCAPING SUPPLIES, INC., LOCATED AT 2840 OLD WINTER GARDEN RD., ORLANDO, FLORIDA 32805.

ARTICLE II- DURATION

THIS CORPORATION SHALL EXIST PERPETUALLY, COMMENCING ON THE DATE OF FILING THESE ARTICLES WITH THE SECRETARY OF STATE.

ARTICLE III- PURPOSE

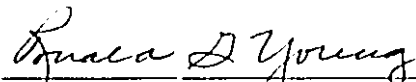
**ARTICLE-IX- PRE-EMPTIVE RIGHTS**

EACH SHAREHOLDER OF THIS CORPORATION SHALL HAVE THE FIRST RIGHT TO PURCHASE SHARES (AND SECURITIES CONVERTIBLE INTO SHARES) OF ANY CLASS, KIND OR SERIES OF STOCK IN THIS CORPORATION THAT MAY FROM TIME TO TIME BE ISSUED (WHETHER OR NOT PRESENTLY AUTHORIZED), INCLUDING SHARES FROM THE TREASURY OF THIS CORPORATION, IN THE RATIO THAT THE NUMBER OF SHARES HE OR SHE HOLDS AT THE TIME OF ISSUE BEARS TO THE TOTAL NUMBER OF SHARES OUTSTANDING, EXCLUSIVE OF TREASURY SHARES. THIS RIGHT SHALL BE DEEMED WAIVED BY ANY SHAREHOLDER WHO DOES NOT EXERCISE IT AND PAY FOR THE SHARES PREEMPTED WITH THIRTY (30) DAYS OF RECEIPT OF NOTICE IN WRITING FROM THE CORPORATION, STATING THE PRICES, TERMS AND CONDITIONS OF THE ISSUE OF SHARES, AND INVITING HIM OR HER TO EXERCISE THEIR PREEMPTIVE RIGHTS. THIS RIGHT MAY ALSO BE WAIVED BY AFFIRMATIVE WRITTEN WAIVER SUBMITTED BY THE SHAREHOLDER TO THE CORPORATION WITHIN THIRTY (30) DAYS OF RECEIPT OF NOTICE FROM THE CORPORATION.

#### ARTICLE X- AMENDMENT

THIS CORPORATION RESERVES THE RIGHT TO AMEND OR REPEAL ANY PROVISIONS CONTAINED IN THESE ARTICLES OF INCORPORATION, OR ANY AMENDMENT HERETO, AND ANY RIGHT CONFERRED UPON THE SHAREHOLDERS IS SUBJECT TO THIS RESERVATION.
