

#### ARTICLES OF INCOPPORATION

OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

## ARTICLE 1.

1.1) Name. The name of the corporation is

The Pines of Mandarin, Inc.

#### ARTICLE 2. Purpose and Powers

- 2.1) <u>Purpose.</u> The purpose or purposes for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this state.
- 2.2) <u>Powers.</u> This corporation shall have all of the powers enumerated in the Florida General Corporation Act.

## ARTICLE 3. Capital Stock

- 4.2) <u>Period of Duration</u>. The period of duration of the corporation is perpetual.

# ARTICLE 5. Initial Registered Office and Agent and Principal Business Office

8.1) Pre-emptive Rights.
