ARTICLES OF INCORPORATION OF T P OF SARASOTA, INC

ARTICLE 1

Name. The name of this corporation is T P of Sarasota, Inc.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III

Purpose. This corporation is organized for the purpose of transacting any or all lawful business.
