ARTICLES OF INCORPORATION OF VOGELSBERGER AND PARTNER, INC.

SECRETALLY OF STATE TALLAHASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of incorporation.

ARTICLE 1 - NAME

The name of the incorporation is VOGELSBERGER AND PARTNER, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida.
