The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

Name

The name of the corporation is Six Oaks of Tallahassee, Inc.

ARTICLE TWO

Commencement of Existence

The existence of the corporation will commence on filing of these Articles of Incorporation.

Purpose
