ARTICLES OF INCORPORATION

The undersigned subscribers being natural persons competent of contract hereby file the following Articles of Incorporation under the laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

210 8/25/95
NAME. The name of the corporation shall be CUDA CORP. *SPORT Fishing*

ARTICLE II

DURATION. This corporation shall exist perpetually.

ARTICLE III

PURPOSE. The purpose of this corporation is to have and exercise any and all powers necessary or convenient to effect its purposes and to otherwise engage in any lawful business permitted under the laws of the State of Florida.

ARTICLE IV

CAPITAL STOCK. This corporation is authorized to issue 100 shares at \$1.00 par value stock. The consideration to be paid for each share shall be fixed by the Board of Directors, but in no event shall be less than One Dollar (\$1.00).

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.

ARTICLE V

INITIAL REGISTERED OFFICE AND AGENT. The street address of the initial registered office of the corporation is 994 S. PARTICK CIRCLE, WEST PALM BEACH, FL 33406 and the registered agent is DE. H. GILLESPIE.

ARTICLE VI

PREEMPTIVE RIGHTS. Each shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII

INITIAL BOARD OF DIRECTORS. This corporation shall have ONE (1) director initially. The number of directors may be either increased or diminished from time to time by the By-Laws but shall never be less than one. The name and addresses of the initial director of the corporation is as follows; LEO C. GILLESPIE, 994 S. PATRICK CIRCLE, WEST PALM BEACH, FL 33406.

ARTICLE VIII

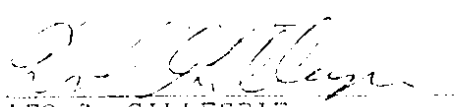
ARTICLE IX

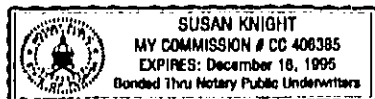
