

**ARTICLES OF INCORPORATION FOR  
THE HOME FOR GENTLE PEOPLE, INC.**

The undersigned, as Incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

**ARTICLE I - NAME**

The name of the corporation is **THE HOME FOR GENTLE PEOPLE, INC.**

**ARTICLE II - DURATION**

The duration of the corporation shall be perpetual and the commencement of the Corporate existence shall begin at the time of the filing of these Articles by the Department of State.

**ARTICLE III - PURPOSE**

The Corporation shall be authorized to engage in acquiring and operating an adult family care home. It shall also be empowered to transact and engage in any and all lawful business for which corporations may be authorized under the laws of the State of Florida.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares of stock of the Corporation shall be one thousand (1000) shares of common capital voting stock, each having a par value of One dollar and No/100 (\$1.00) dollar for a total authorized capitalization of One thousand dollars and No/100 (\$1,000.00).

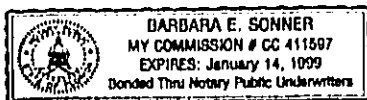
