ARTICLES OF INCORPORATION

The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be Irvin Komray Blacketer Construction, Inc. The principal place of business of this corporation shall be 315 Harris Court, North Fort Myers, FL 33917.

ARTICLE IL. NATURE OF BUSINESS
