ARTICLE I - NAME

The name of the corporation is ASOTV Financial Corp.
(hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have the authority to issue is 1,000 shares of Common Stock, par value \$.01 per share.

ARTICLE IV - INITIAL REGISTERED AGENT

The street address of the initial registered office of the Corporation is 138 North County Road, Palm Beach, Florida 33480; and the name of the initial registered agent of the Corporation at that address is Martin A. List.

ARTICLE V - MAILING ADDRESS

ARTICLE VII - INCORPORATOR


