ARTICLES OF INCORPORATION
OF
Mills & Mills Association, Inc.

The undersigned, subscribers to these articles of Incorporation, natural persons at least 18 years of age, competent to contract, for the purpose of forming a corporation under the laws of the state of Florida, hereby adopt the following Articles of Incorporation:

Article I

Name

The name of the corporation shall be: Mills & Mills Association Inc.

Principal office 185 McMahon Dr., Crawfordville, FL. 32327

Article II

Term of Existence

The corporation shall have perpetual existence, commencing with the filing of these Articles with the Secretary of State, Division of Corporations, State of Florida.

Article III

General Nature of Purpose

The general nature of business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the state of Florida, and more particularly but not limited to Tractor and Back-hoe Services.

Article IV

Capital Stock

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is 2,500 shares of common stock having a par value of \$1.00 per share.

Each holder of common stock shall have one vote for each share of such stock held. The whole or any part of the capital stock of this corporation shall be payable in lawful money of the United States or prior labor or services at a price valuation to be fixed by the Directors.

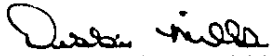

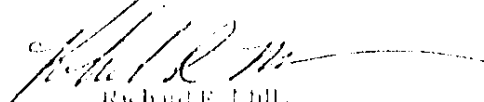
