**Re: The enclosed Uniform Business Report**

I recently received a notice that you had not received our filing fee. I checked with my bookkeeper and she says that it was mailed along with several others on May 31st. I have checked my bank records for the month of June and I do not see a cancelled check, which was in the amount of \$150.00.

I spoke with a lady in your office and asked her if there was any way they could look to see if there was a reason the check might have been refused or not deposited. She told me that according to your records, you had never even received the filing or the check.

I then asked her if there could be any exception made in this case regarding the \$400.00 in additional charges. We are a very small company (only myself, my wife, and her mother) and this penalty would be an extreme hardship for us to cover.

We have never failed to pay all of our fees on time and I certainly did not intentionally fail to return the form on time and with the proper amount enclosed. Since the check was never passed through our bank, all I can do is assume that it was misplaced in the mail. I can only provide you with a check number from our stubs where we wrote the check as proof that it was written.

Your employee told me to enclose this letter of explanation along with the copy of the UBR which I now have and another check for the original amount of \$150.00 and that perhaps, under the circumstances, you might be willing to drop the \$400.00 penalty. I am sending this letter by way of Fedex Overnight Courier to make sure that it gets there.

We would sincerely appreciate your giving this request your kind consideration.

If you are unable to help with this, please be sure to let me know and we will get you the rest of the money before the next deadline.
