**ARTICLES OF INCORPORATION  
OF  
EXPERT ENGINEERING, INC.**

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation.

**ARTICLE I - NAME**

The name of the corporation shall be: EXPERT ENGINEERING, INC.

**ARTICLE II - CORPORATE DURATION**

The corporation shall commence to be in existence upon the filing of these Articles of Incorporation by the Department of the State of Florida and the term of existence shall be perpetual.

**ARTICLE III - PURPOSES**

The purpose of the corporation is to engage in business of sales and installation of mailboxes and accessories.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors, be advantageously carried on in connection with or auxiliary to the foregoing business.

To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE IV - CAPITALIZATION**

The aggregate number of shares that the corporation shall have authority to issue is 500 shares, all of which shall be common shares with individual par value of \$1.00.

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than ten persons. Stock will be issued and transferred only to (1) natural persons, (2) estates, or (3) a trust as described in title 26 United States Code Section 1371 defining a qualified "small business corporation".

#### ARTICLE V - PRINCIPAL OFFICE AND REGISTERED AGENT

The street address of the initial principal office of the corporation shall be 4901 Thomas Street, Hollywood, Florida, 33021. The name of the initial registered agent shall be DAVID KUPPERMAN, ESQ., whose office is located at 1013 N.W. 107th Avenue, Pembroke Pines, Florida 33026.

#### ARTICLE VI - DIRECTORS
