

ARTICLES OF INCORPORATION

FOR

MAJESTIC DRY CLEANERS AND LAUNDRY, INC.

The undersigned subscriber to these articles of incorporation, desires to form a corporation under the laws of the State of Florida, and does hereby accept all rights and privileges, benefits and obligations conferred and imposed by the laws of the State of Florida and hereby adopts the following articles of incorporation as the Charter of the corporation hereby organized.

ARTICLE I

NAME

The name of the Corporation shall be MAJESTIC DRY CLEANERS AND LAUNDRY, INC. and shall have the address of 9306 Rockport Place, Tampa, FL 33626.

ARTICLE II

DURATION OF EXISTENCE

The corporation shall have perpetual existence, commencing with the filing of these articles of incorporation.

ARTICLE III

PURPOSES AND POWERS

This corporation is organized for the purpose of engaging in all lawful business activities.

ARTICLE IV

CAPITAL STOCK

The amount of capital stock authorized shall consist of 10,000 shares of common voting stock with a par value of ten cents (U.S.) \$.10 each. Dividends to shareholders may, in the discretion of the Board of Directors, be paid in cash or in property, but no dividend may be made which would impair the restricted or reserved unearned surplus of the corporation, except as provided by Florida law.

ARTICLE V
SHARES NOT TO BE DIVIDED

The shares of the capital stock of the Corporation are not to be divided into classes.

ARTICLE VI
RESTRICTIONS ON TRANSFER

The board of Directors may, in its discretion, include within the Bylaws of the corporation restrictions on the transfers of shares of stock in the Corporation.

ARTICLE VII
NO SHARES ISSUED IN A SERIES

The shares of the capital stock are not to be issued in series.

ARTICLE VIII
INITIAL OFFICE AND REGISTERED AGENT

The initial registered office of this corporation is 9306 Rockport Place, Tampa, FL 33626. The initial registered agent shall be Cynthia A. Dreier.

ARTICLE IX
INITIAL BOARD OF DIRECTORS

This corporation shall have one director initially. The number of directors may be either increased or decreased from time to time by action of the board and in accordance with the provision of the bylaws. The name and address of the initial director is:

ARTICLE X
MEETINGS

The shareholders and directors of this corporation shall meet at least once annually at the corporations's principal office on the annual date of the execution of these articles or at such other time and place as may be provided in the Bylaws.

This corporation shall have three (3) officers: a president, a secretary and a treasurer, with such duties as shall be by the laws of the State of Florida. The initial officers and offices of this corporation are:

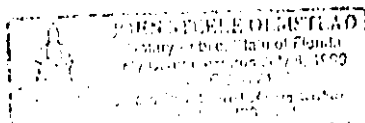


