

#### ARTICLES OF INCORPORATION

#### FOR

#### MAJESTIC DRY CLEANERS AND LAUNDRY, INC.

The undersigned subscriber to these articles of incorporation, desires to form a corporation under the laws of the State of Florida, and does hereby accept all rights and privileges, benefits and obligations conferred and imposed by the laws of the State of Florida and hereby adopts the following articles of incorporation as the Charter of the corporation hereby organized.

#### **ARTICLE 1**

NAME

The name of the Corporation shall be MAJESTIC DRY CLEANERS AND LAUNDRY, INC. and shall have the address of 9306 Rockport Place, Tampa, FL 33626.

## ARTICLE II DURATION OF EXISTENCE

The corporation shall have perpetual existence, commencing with the filing of these articles of incorporation.

#### ARTICLE III PURPOSES AND POWERS

This corporation is organized for the purpose of engaging in all lawful business activities.

#### ARTICLE IV CAPITAL STOCK

## ARTICLE VII NO SHARES ISSUED IN A SERIES

The shares of the capital stock are not to be issued in series.

#### ARTICLE VIII INITIAL OFFICE AND REGISTERED AGENT

The initial registered office of this corporation is 9306 Rockport Place, Tampa, FL 33626. The initial registered agent shall be Cynthia A. Dreier.
