ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of the corporation shall be AQUA AL DUE, INC. whose mailing address is 128 Alder Avenue, Altamonte Springs, FL, 32714.

ARTICLE II - DURATION

The corporation shall exist perpetually.


