ARTICLES OF INCORPORATION
OF
STAT DIAGNOSTIC LABORATORIES, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name

The name of the corporation is: "STAT DIAGNOSTIC LABORATORIES, INC".

Article II - Principal Office

The principal place of business and the mailing address of this corporation is: 6701 - 16 Avenue North
St. Petersburg, Florida 33710

Article III - Duration

This corporation shall have perpetual existence unless terminated or dissolved as provided by law.

Article IV - Purpose

This corporation may engage in any activity or business permitted under the laws of the United States and of this state.

Article V - Capital Stock and Voting Rights

This corporation is authorized to issue two hundred (200) shares of One Dollar (\$1.00) par value, Common Stock, which shall be designated "Common Shares".

The holders of the stock of the corporation shall be entitled to one vote for each share of stock held, at all meetings of the stockholders, regardless of the purpose of such meetings and regardless of the matter voted upon.

Article VI - Initial Registered Agent and Address

Article VII - Directors

Section A. The management and control of this corporation shall be vested in a Board of Directors of not less than one member. The number of directors may be varied from time to time by the by-laws adopted by the stockholders, but shall never be less

than one.

Section B. The Board of Directors shall be elected by the stockholders at each annual meeting to be held at the principal office of the corporation or at such other place as shall be designated in and by the notice of the meeting. 
