The undersigned incorporator for purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

FIRET: The name of the Corporation is THE FLORIDA INSTITUTE OF REHABILITATION AND SPORTS THERAPY, INC. (the "Corporation").

SECOND: The street address of the initial principal office and mailing address of the Corporation is 1627 Highway U.S. 1, Suite 2B, Sebastian, Florida 32958.

THIRD: The Corporation is authorized to issue 1,000 shares of common stock, par value \$1.00 per share.
