I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articless of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE_I

The name and initial address of this Corporation shall be: TREATMENT RESOURCES OF BROWARD, INC., 2040 Northeast 163rd Street, Suite 307, North Miami Beach, Florida 33162.

ARTICLE II

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.
