ARTICLES OF INCORPORATION OF CHURCH RISK MANAGEMENT, INC. (a corporation for profit)

The undersigned, for the purpose of forming a corporation for profit under the provisions of the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporations

ARTICLE I

The name of this corporation is CHURCH RISK MANAGEMENT, INC

ARTICLE II DURATION

This corporation shall have perpetual duration. The corporate existence shall begin with the date and time of the filing of these Articles of Incorporation by the Florida Department of State.

ARTICLE III PURPOSES AND POWERS
