

ARTICLES OF INCORPORATION

OF

MAHA BONES, INC.

ARTICLE I. NAME AND ADDRESS. THE NAME OF THIS CORPORATION SHALL BE Maha Bones, Inc., and its principal office is: 13613 SW 179 Street, Miami, Florida 33177.

ARTICLE II. DURATION. THIS CORPORATION IS TO EXIST PERPETUALLY.

ARTICLE III. PURPOSE. This corporation is organized for the Purpose of the transaction of any lawful business for which corporations may be incorporated under the laws of the State of Florida.




