

ARTICLES OF INCORPORATION

OF

INTERNET CONNECTIONS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I -- NAME

The name of the corporation shall be INTERNET CONNECTIONS, INC.

ARTICLE II -- NATURE OF BUSINESS




