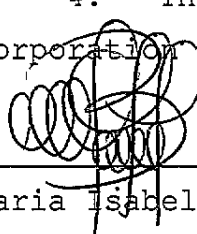
'BEFORE ME, the undersigned authority, this day personally appeared Maria Isabel Garcia and Jose Francone, who first by me being duly sworn deposes and says:
