OF

AGWIRE, INC.

THIS IS TO CERTIFY that I, the undersigned, hereby, for the purpose of forming a corporation for profit under and by virtue of the laws of the State of Florida, have adopted and do hereby certify the following as my Articles of Incorporation.

ARTICLE I

The name of this corporation shall be AGWIRE, INC., and its principal place of business shall be 230 Central Avenue, Crescent City, FL 32112, with the privilege and right of establishing and maintaining such other place or places of business and offices and agencies elsewhere in the State of Florida, and in any other state of the United States other than the State of Florida, as the Corporation may hereinafter desire and determine.

ARTICLE II

The general nature of the business or businesses to be transacted by the Corporation shall be to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
