ARTICLES OF INCORPORATION

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of Incorporation.

ARTICLE ONE - NAME

The name of the corporation is **JOSHOMIE INC.**

ARTICLE TWO - DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE - PURPOSE

The purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and the State Of Florida.

ARTICLE FOUR - CAPITAL STOCK

The aggregate number of shares that the corporation shall have the authority to issue is 1,000 shares of capital stock with a par value of \$1.00 per share.

FIVE HUNDRED (500) shares of the capital stock of the corporation shall be issued for cash at a par value of \$1.00 per share. The sum of the par value of all shares of capital stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time. The shares of the corporation are not to be divided into classes.

ARTICLE FIVE - DIVIDENDS

The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

ARTICLE SIX - PREEMPTIVE RIGHTS

Every shareholder, upon the sales for cash of any new stock of this corporation, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE SEVEN - INITIAL REGISTERED OFFICE AND AGENT.

The principal address and the initial mailing address of the corporation is 18495 South Dixie Hwy. Miami Fl 33157 and the name and address of the initial registered agent of this corporation is **Meera Khan of 9910 Dominican Drive, Miami Florida 33189** who by her signature attest that as a subscriber and as the registered agent she is familiar with, and accept the duties and responsibilities as the registered agent for said corporation.

ARTICLE EIGHT - INITIAL BOARD OF DIRECTORS

This corporation reserves the rights to amend or repeal any provisions contained in these articles of incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.
