ARTICLES OF INCORPORATION
of
ALL ADVANCED INSURANCE, INC.

The undersigned subscriber to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is ALL ADVANCED INSURANCE, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business is the sale of insurance and, related products and distribution, sale, and rental of products; and to purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description, including construction.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock. The consideration to be paid for each share shall be fixed by the Board of Directors. The initial par value shall be \$1.00 per share.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin business is in excess of five hundred (\$500.00) dollars.

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

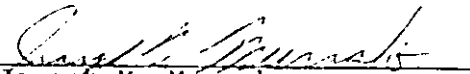
