ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TRI-EIGHTS DEVELOPMENT INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1st. The name of this Corporation is TRI-EIGHTS DEVELOPMENT INC...
- 2nd. Article IV of the Articles of Incorporation is deleted and replaced by new Article IV, as follows:

ARTICLE IV

The aggregate number of shares which this Corporation shall have authority to issue is One Hundred Thousand shares (100,000). Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.
