The undersigned subscribers to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The general nature of the business to be transacted by this corporation is: *retail sales of books and other software*
