**Article I. Corporate Name and Initial Corporate Address**

The name of this corporation is **Yellow Checker Cab Company of Bay County, Inc.**, and the initial corporate address is 703 West 13th Street, Panama City, Florida 32401

**Article II. Nature of Business and Powers**

The general nature of the business to be transacted by this corporation is to engage in any and all business permitted under the laws of the State of Florida.

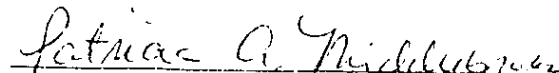
