ARTICLE I

OFFICERS AND DIRECTORS

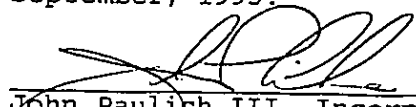

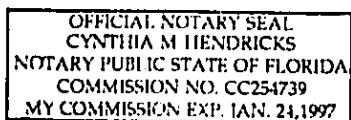
