**ARTICLE ONE**

The name of the corporation is:

The powers of the incorporators cease upon filing of the Articles of Incorporation.

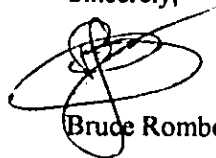
