CERTIFICATE OF INCORPORATION OF PARKING ASSOCIATES, INC.

The undersigned does hereby sign this Certificate of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLEL

The name of the corporation shall be PARKING ASSOCIATES, INC.

Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors or Stockholders.

ARTICLE IL

The general nature of the business to be transacted by the corporation and the powers and rights of the corporation shall include any or all lawful business.

To buy and sell real estate, build and develop unimproved land and conduct a general brokerage business on all forms or kinds of securities and to act as agents in the buying and selling of mortgages, equities, securities, and other forms of negotiable instruments and evidence of indebtedness, and to buy and sell personal property, either wholesale or retail; to purchase, own, sell, rent, lease, mortgage and to act as the agent in the buying, owning, selling, renting, leasing, and mortgaging of property, whether real or personal or otherwise to manufacture, acquire, or dispose of real estate or personal properties, equities, and securities of whatever nature or kind for both cash and oredit; to buy and sell bonds, stocks, notes, mortgages or other indebtedness or security, to loan money, either for itself or setting as agents in loaning and buying securities; to borrow money and to accure the same in whatever manner in which a corporation might do and is permissable under the laws of the State of Florids.

Sue and be sued and appear and defend in all actions and proceedings in its corporate name to the same extent as a natural person.
