**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
COMMERCIAL MAINTENANCE ORGANIZATION, INC.**

The following provisions of the Articles of Incorporation of Commercial Maintenance Organization, Inc., a Florida corporation (the "Corporation"), filed with the Department of State on September 14, 1996, document number P95000071094, be, and they are hereby, amended as shown below:

Article One of the Articles of Incorporation of this Corporation is hereby amended to read in its entirety as follows:

ARTICLE ONE

The name of the Corporation shall be:

R. Cole Corp.

Article Two of the Articles of Incorporation of this Corporation is hereby amended to read in its entirety as follows:

ARTICLE TWO

This Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, except to the extent prohibited by that certain Covenant Not To Compete entered into by the Corporation in favor of ISS Technology, Inc. dated July 31, 1998.

The foregoing amendment was adopted by a Consent Action In Lieu of Special Meeting of the Board of Directors of this Corporation, dated the 7 day of August, 1998.

The Shareholders of this Corporation approved the foregoing amendment by a majority vote of the Shareholders which majority vote was sufficient for Shareholder approval on August 7, 1998.
