

OF

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is **Win-Net International, Inc.** The principal place of business of this corporation shall be 641 Deer Run Court, Casselberry, Florida 32707.

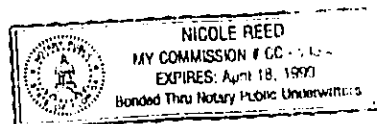
