ARTICLES OF INCORPORATION

of

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

The name of the Corporation is Subjeck, Inc.

ARTICLE II - INITIAL CORPORATE ADDRESS

The office of the Corporation is located at 8829 U.S. 19, Port Richey, FL 34668.

ARTICLE III - DURATION

The Corporation shall exist perpetually unless dissolved according to Florida Law.

ARTICLE IV - PURPOSE

The Corporation is organized for the purpose of engaging in used car sales and any activities or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE V - CAPITAL STOCK

The Corporation is authorized to issue FIVE HUNDRED shares (500) of ONE DOLLAR (\$1.00) par value Common Stock, which shall be designated "Common Shares."


