ARTICLES OF INCORPORATION
OF

ACUTE FASTENERS INC.

The undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. CORPORATE NAME

The name of this corporation is: ACUTE FASTENERS INC..

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business which is to be transacted by this corporation is is any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 7000 shares of common stock at one dollar par value. The consideration to be paid for each share shall be fixed by the Board of Directors. The stock so issued shall be fully paid and non-assessable.

ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation will begin business is One Hundred (\$100.00).

ARTICLE V. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI. PRINCIPAL OFFICE

The initial principal office address of this corporation is 16657 Redwood Way, Ft. Lauderdale, FL, 33326.

The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE VII. BOARD OF DIRECTORS

ARTICLE XI. AMENDMENT

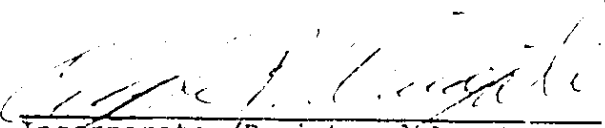

ARTICLE XI.1

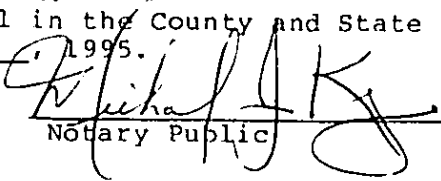
The corporation shall indemnify any officer or director to the full extent of the law.
