
Every person now or hereafter serving as director, officer or

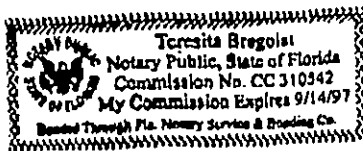


