1. The name of the corporation is:

WebReach International Inc.

2. The principal place of business and mailing address of the corporation is:

906 Village Lane, Winter Park, FL 32792

3. The corporation shall have the authority to issue 100 shares of common stock, in one class only, each with a par value of \$0.01.

4. The registered agent of the corporation is Barry Sowder, and the registered address is:

5. The initial Board of Directors shall have four members whose names and addresses are as follows:

The number of Directors may be raised or lowered by amendment of the Bylaws of the corporation, but shall in no case be less than one.

6. Any shareholder may request the Board of Directors to dissolve the corporation, regardless of the number of shares held. Upon receipt of a written dissolution request by any shareholder, the Board of Directors will dissolve the corporation in the manner described within the Bylaws of the corporation. The Bylaws will contain provisions for a shareholder requested dissolution.
7. Board, Executive, and Director compensation along with stock dividends must be unanimously approved by all directors. The Bylaws will contain provisions for approval procedures. A unanimous approval by all Board directors is required to alter this provision, including but not limited to the requirement for unanimous consensus.
