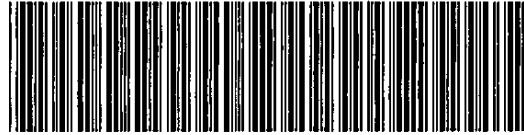

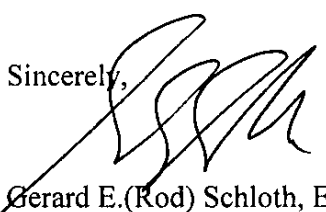

THIRD: The amendment was approved by a majority of the members of the corporation on the 6th day of November, 2006

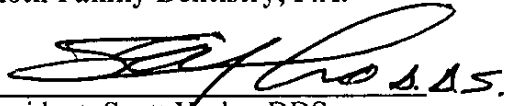
