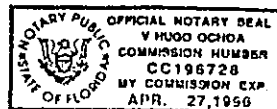

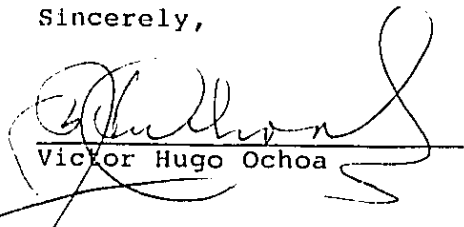
Mr. Harris;
