ARTICLES OF INCORPORATION

The undersigned, Coastal Health & Nutrition, Inc., acting as Incorporators of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

- Name. The name of the corporation is ZEPHYRHILLS HEALTH & NUTRITION, INC.
 - 2. <u>Duration</u>. The period of its duration is perpetual.
- 3 <u>Purpose</u>. The purpose is to engage in the selling of nutritional supplements and any other activity of business permitted under the laws of the United States and Florida.
- 4. <u>Capital Stock</u>. The corporation is authorized to issue 50,000 shares, all of one class, at One (\$1.00) Dollar par value. The corporation elects to have preemptive rights assigned to the shares of stock issued by the corporation.
